- **APICS (USA)**: Certified in Production and Inventory Management (CPIM) and Certified in Logistics, Transportation & Distribution (CLTD).
- **CSCMP (USA)**: Supply Chain Pro Certification (SCPRO) Level 1.

It incorporates the core content of CPIM and SCPRO, with selected elements from CLTD, while adding the advantage of structured workplace learning.

### 5. Occupational Trainer – NQF Level 4 Certification

Learners must have completed an appropriate **Occupational Trainer qualification or an equivalent NQF Level 4 certificate** as a foundation before entering this Level 5 programme.
